### **Privacy Matters Corner...**



In May 2024, Health PEI announced a change to the process for staff to access their own information in CIS. Staff are now required to follow the same process as patients when requesting information from their own chart, instead of completing a form and sending it to Health Records to access the information in CIS themselves.

In an effort to make this process more efficient for everyone, Health Records developed an online release of information [web form](#) that is available to everyone, 24/7.

This change to how we access our records was necessary to ensure Health PEI is following the *Health Information Act* and privacy best practices. It also makes our practices consistent across all our digital health information systems, as well as with other provinces and with guidance from healthcare provider professional associations.

Health PEI's Access to Information and Privacy (ATIP) team would like to remind all staff about this change and ask that you use the available web form to request your own health information. 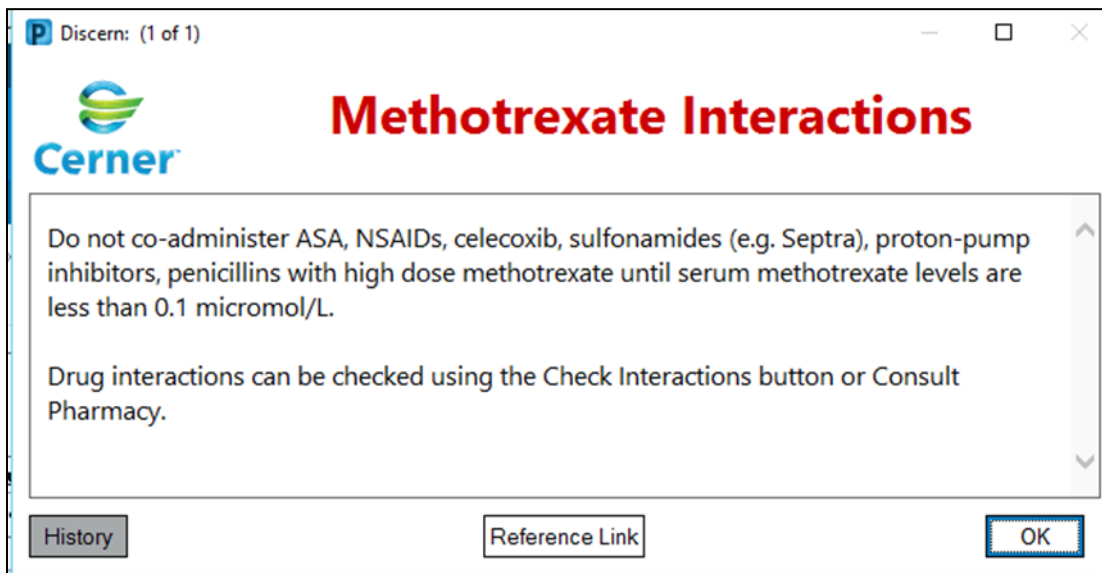
## Provincial Drugs & Therapeutics (PD&T) Updates:

**Methotrexate Interactions Alert** - An alert regarding clinically significant drug interactions will fire for patients receiving high dose methotrexate for oncology.

High dose methotrexate treatment is ordered through the PEICTC High Dose Methotrexate Order Set on PowerChart.

The alert will fire when:

- 1) The incoming order is for methotrexate within the High Dose Methotrexate Order Set
- OR
- 2) Any medication order (stand alone or through an order set) is being entered AND methotrexate has already been ordered via the High Dose Methotrexate Order Set with a start date within the preceding 10 days.



### Alert Specifics

- The alert fires on PowerChart for those entering the order and MedManager for pharmacists verifying the medication order.
- The alert will be limited to health care providers that can place orders for medications (physicians, nurses, nurse practitioners, pharmacists, respiratory therapists, etc).
- The alert will be suppressed if the same user has seen the alert within the last 15 minutes.
