Privacy Matters Corner...



Always log out of CIS before you walk away from your computer! This is especially important to remember when working in clinical areas where staff are sharing computers. Logging in and out is necessary to protect the privacy of patients but it also protects you! Anything that is accessed or

added while you are logged in, is your responsibility! You must also ensure that you are charting/documenting under your own login for accuracy of records. It is a legal requirement and professional obligation to protect privacy and to keep accurate records. Therapeutic Interchange of Lovenox to Redesca for enoxaparin

PD&T has approved the selection of Redesca as the preferred biosimilar to be used in place of Lovenox in Health PEI facilities. A therapeutic interchange to switch Lovenox orders to Redesca has also been approved by PD&T, and will be implemented within CIS. A more detailed communication will be sent out closer to the planned implementation date of June 14

New Workflow for Transitions in Care: ED to Mental Health Care

Quick Views/ED Documentation: Transport/Transfer section

New fields have been added to support the transition of care for patients leaving the ED's and going to Mental Health or Addictions. Conditional fields expand when either **Transfer to Addictions or Transfer to Mental Health** is selected.

The activated fields have been created to ensure the staff at the receiving facilities receive the information required for Mental Health and Addictions Transitions in Care documentation standards.
