



## **Occupational Health and Safety**

The **Joint Occupational Health and Safety Committee** is committed to fostering a safe and healthy work environment across the five Home Care offices and the Geriatric Program. Co-chaired by Angela Johnston (Manager, Queens) and Jim Ryan (Home Support Worker, Queens), the committee brings together a diverse team of 21 members. Membership includes strong representation from each of the Home Care Sites and Geriatric Program as well as, the three unions—IUOE, UPSE, and PEINU. Participants from other Health PEI areas such as Occupational Health & Safety (OH&S), Musculoskeletal Injury Prevention (MSIP), Infection Control, and Employee Health attend on a Ad Hoc basis.

The OH&S Committee plays a vital role in:

- recommending improvements to employee health and safety.
- monitoring causes and corrective actions for reported employee events through the PSMS system.
- reviewing incident reports to identify trends and suggest preventative measures to Leadership.
- workplace inspections and recommendations for improvements.
- · training and education.

Staff are encouraged to bring forward health and safety concerns to any committee member for inclusion in the next meeting agenda, ensuring open communication and proactive problem-solving.

In addition to its core work, the OH&S committee includes several sub-committees, focusing on specialized areas such as Emergency Management and <u>Environmental Hazards</u>. ## **Provincial Palliative Care Programs**



Please join us in extending a warm welcome to **Dr. Jason Kallestad!** Dr. Kallestad joins us as our third full-time palliative care physician and has quickly become a valued part of our team. His arrival marks an important milestone for our program, enabling us to expand our presence across facilities throughout Prince Edward Island, specifically in community and outpatient settings.



Originally from Minnesota, Dr. Kallestad is a family medicine-trained palliative care physician with extensive experience across a variety of care environments. His compassionate approach and diverse background will be a tremendous asset to our team and to the patients and families we serve.

We appreciate your patience and support as we proceed with the onboarding and orientation of Dr. Kallestad and other new team members.

Dr. Kallestad recently joined the team at the Provincial Palliative Care Centre for the CIBC Run for the Cure, in support of breast cancer research and support. Great work, team!



## **Medication Assistance Program (MAP)**

MAP supports clients in safely taking their medications as prescribed. Services are tailored to each client's needs, ranging from verbal reminders to partial or full assistance **provided by home support workers** (Levels 1-3).

MAP began as a pilot in East Prince in January 2023 and has since expanded right across the province with final site, West Prince, implementing in May 2025. The Provincial MAP Committee—a collaborative team—continues to meet monthly to identify challenges and refine the program through an iterative, responsive approach.

Each site has undergone a six-month evaluation (West Prince evaluation is pending), and incident reporting is actively encouraged, with trends reviewed regularly to support continuous improvement. The pilot has been featured at a Quality & Patient Safety Learning Exchange.

While enrollment is limited by capacity, MAP is now a provincial program. MAP is successful because of the strong collaboration between schedulers, HSWs, HSTLs, LPN supports and Pharmacy. Kudos to all who have helped this grow province-wide. We remain committed to expanding our ability to support safe medication management for clients living at home who are unable to manage their medications independently.

MAP education has been developed under the leadership of Dawn Mallard, Provincial Nursing Clinical Development Coordinator, Trent Ferrish and Ashton Muttart, Home Care Pharmacists. In a continued commitment to quality and safety, a MAP education working group recently enhanced the training to include MAP simulations and an initial LPN supervised visit. These additions complement existing self-directed learning and virtual group education.

# French Services/ Official Languages Recognition Program (OLRP)

Congratulations to Melissa Long, RN, who received the <u>"Étoile Santé" Award from the PEI French Health</u> <u>Network</u> for her exceptional service to the Frenchspeaking community.

As a bilingual care coordinator with Home Care - Prince County, Melissa ensures clients receive compassionate care in their official language of choice - making a real difference in their care experience. "When a client requests home care, we ask for their preferred language. If they indicate French, I am the first point of contact and I follow them from start to finish," says Melissa. For some clients, having access to care in French brings comfort, clarity and confidentce - especially when they are very ill and communication is difficult.

"It takes even more effort for them to express their feelings and needs, it's really important that they understand the information being given to them in order to comply with medication adherence, understand possible side effects, their physical limitations, etc." Melissa's dedication is helping improve access and equity in health care across the Island. Bravo!
