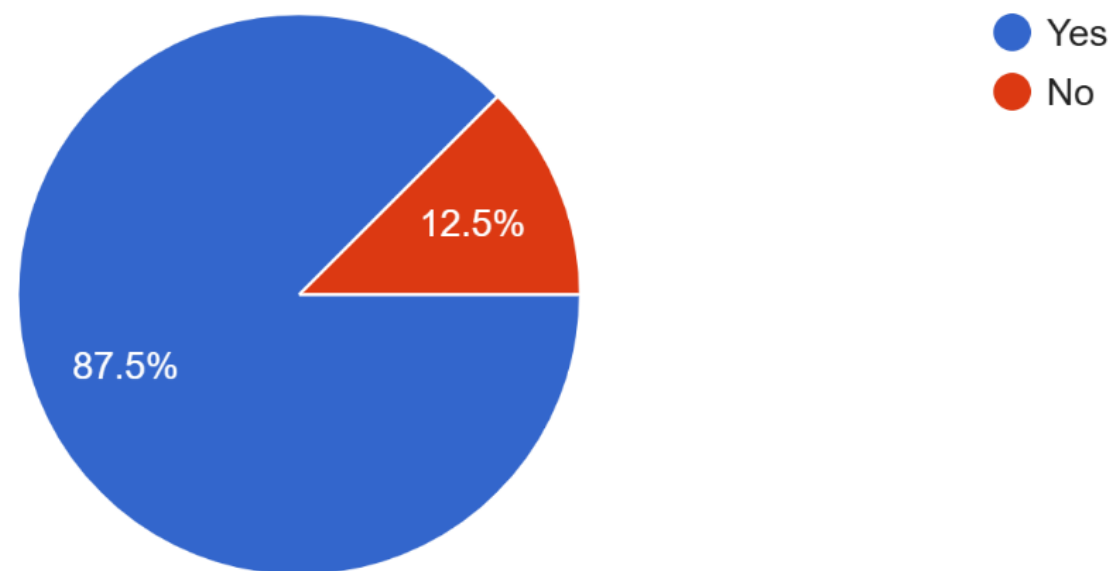

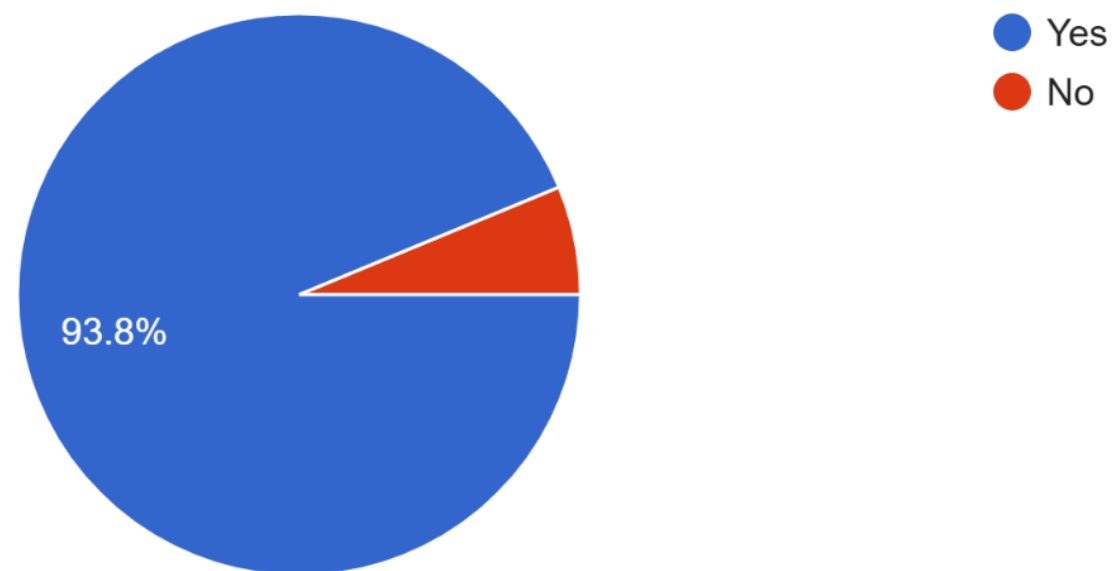
Were you aware that Health PEI has an Antimicrobial Stewardship Program?

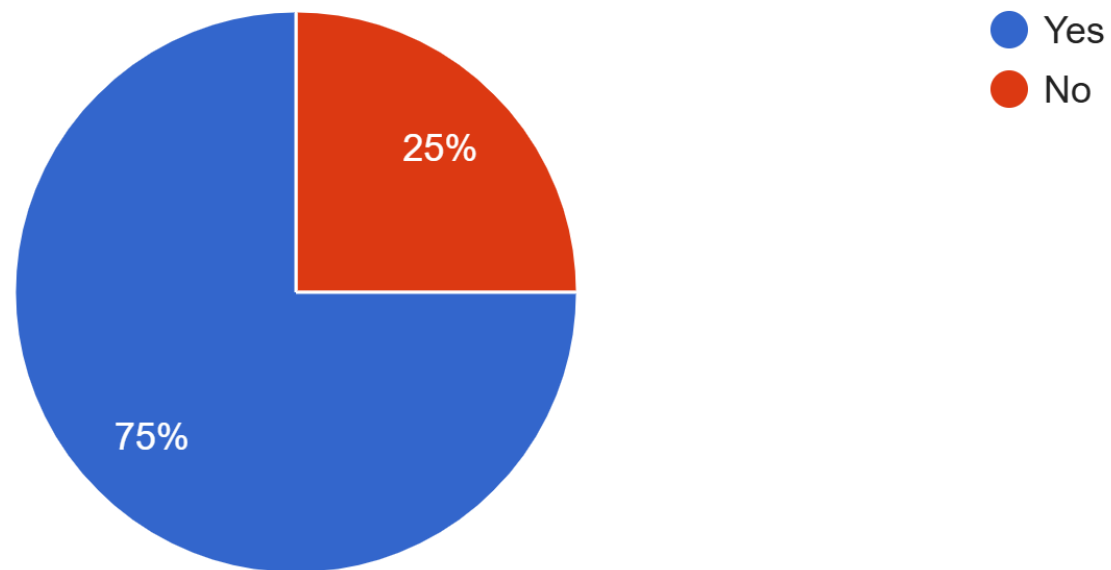

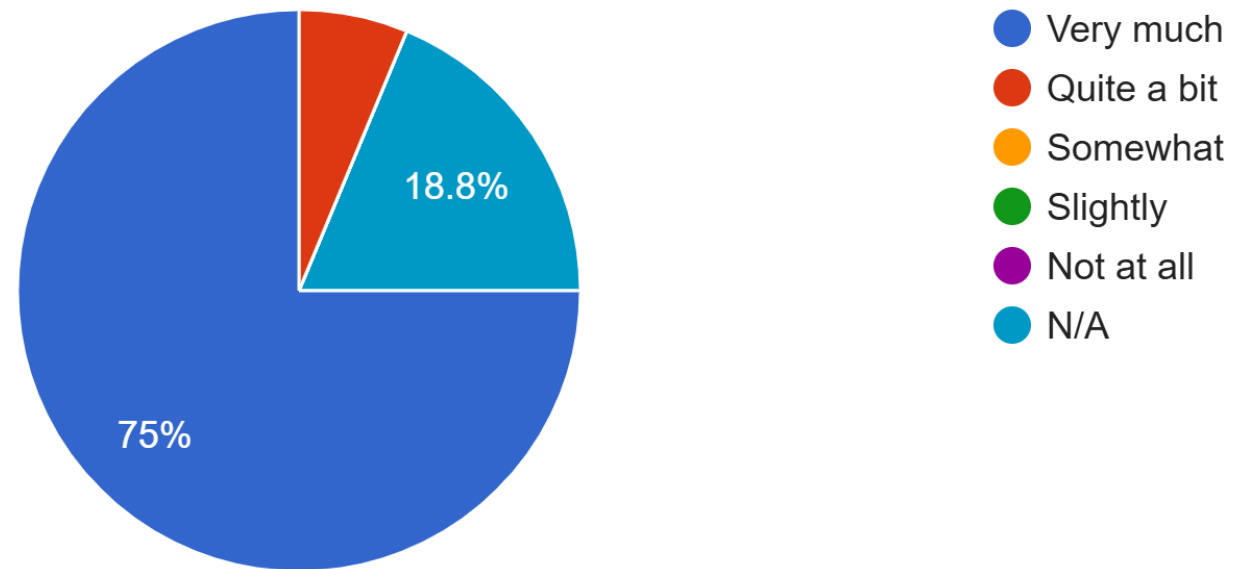

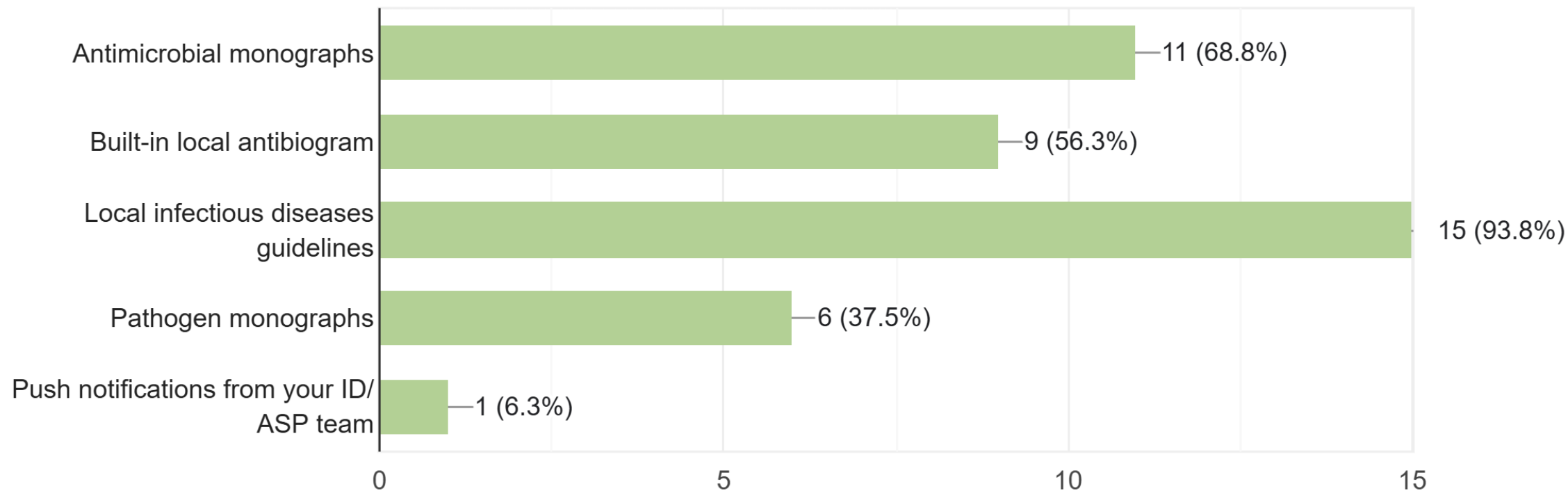

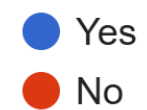

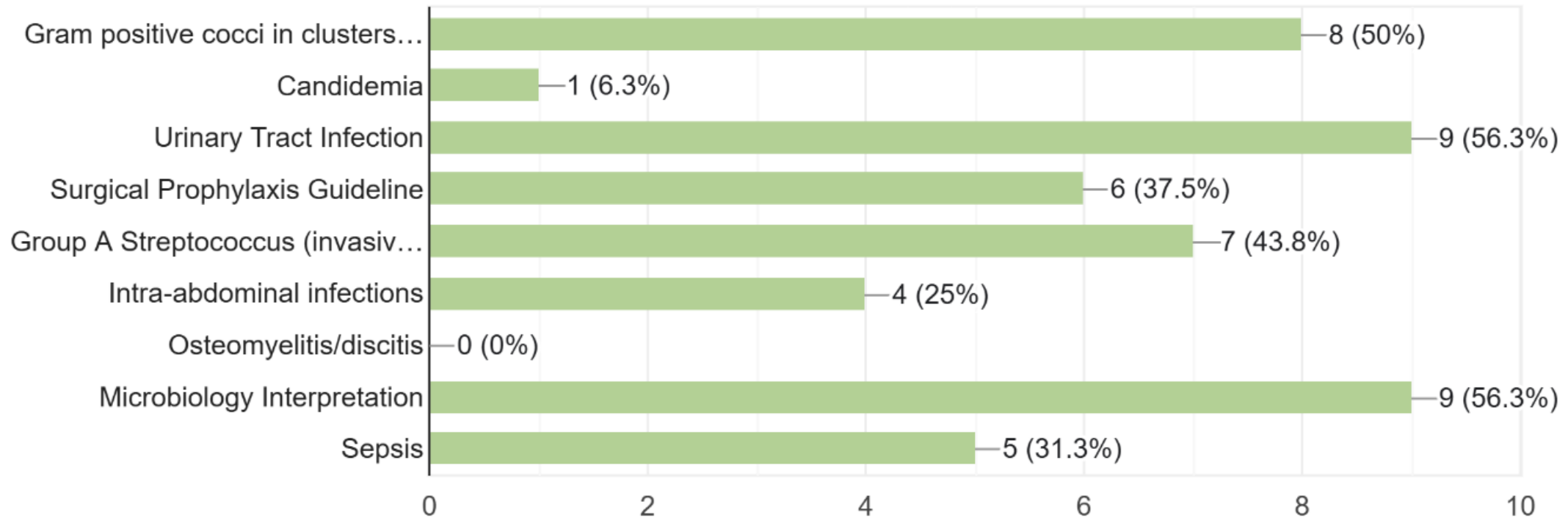

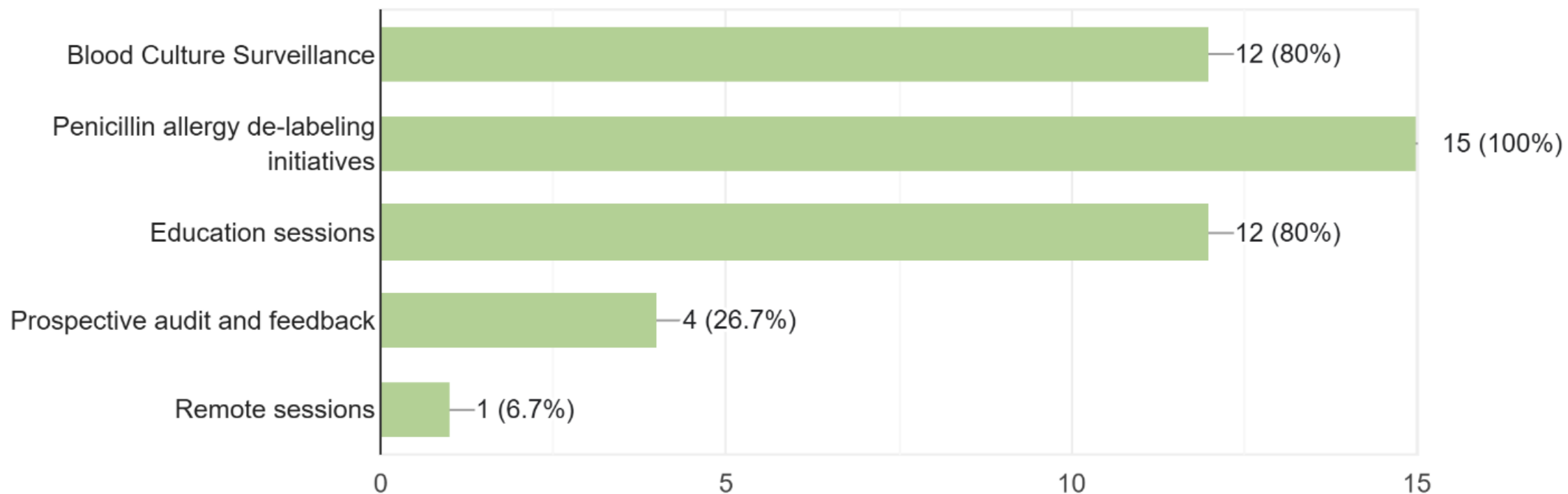

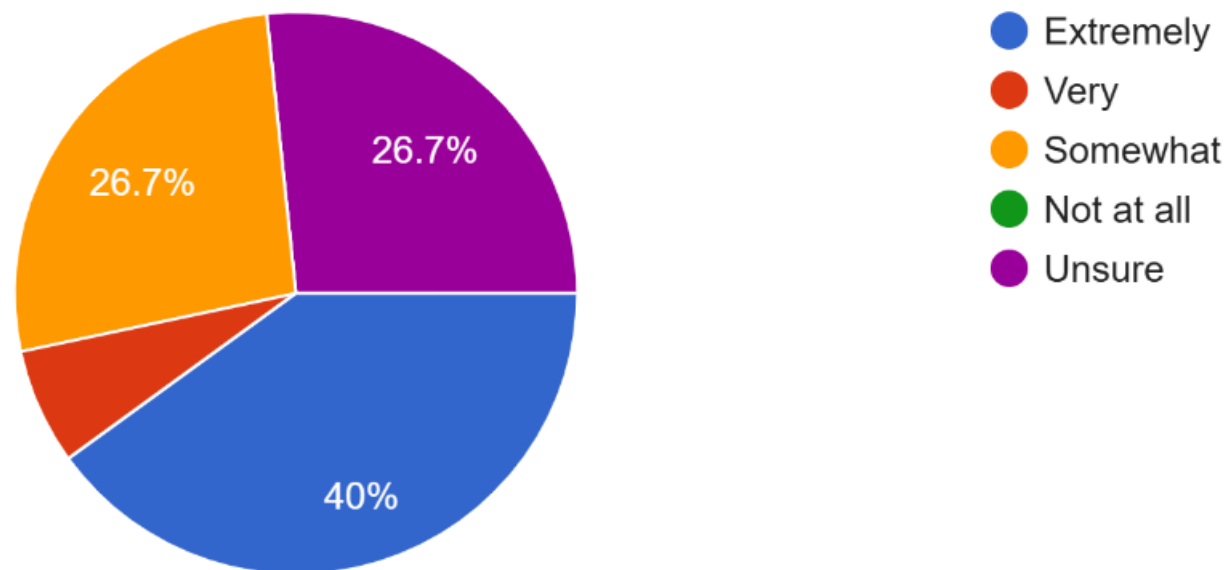

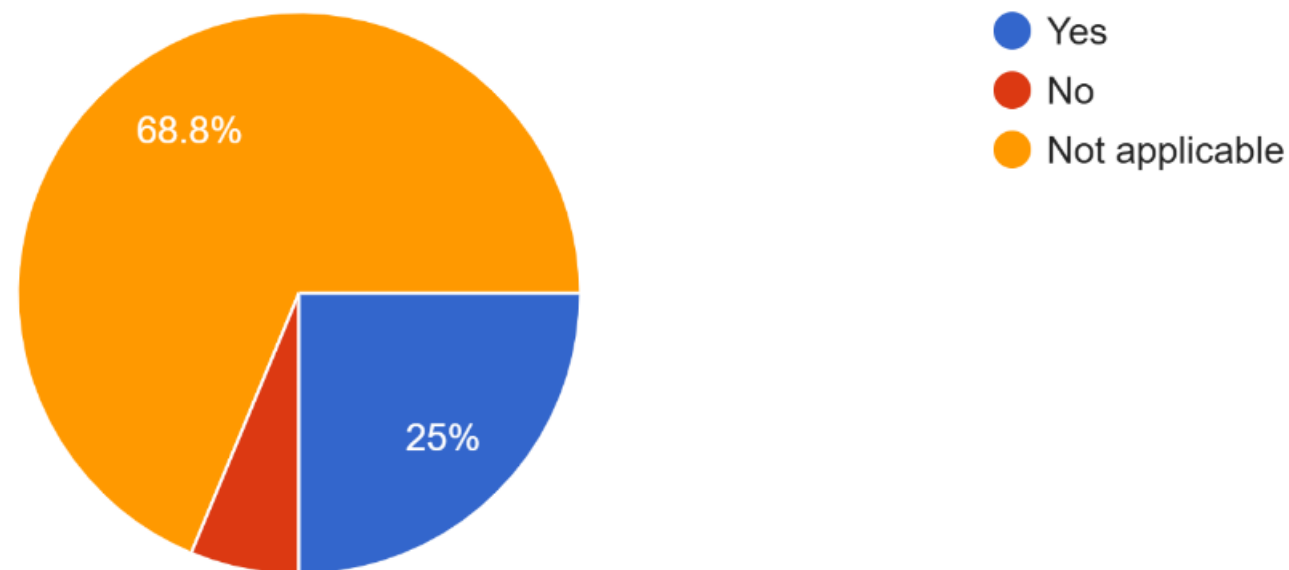
Any antibiotics started in hospital would be automatically covered.

Similarly to some oncology medications, if the prescribed antimicrobial is written by ID physician in PEI, then the SA process could be eliminated and the patient would only have to apply to the corresponding channel in Pharmacare (ex: high cost program; etc). The paper SA is not required for oncology meds on the formulary if ordered by a PEI oncologist.
