## Truth and Reconciliation

**September 30** marks the National Day for **Truth and Reconciliation**. On this day, we would like to honour those who have lived on Turtle Island for over 12,000 years. It is a day to reflect on the truth of what was taken from those who lived here, and how to move forward and

reconcile.

### Understanding:

- Settlers and Indigenous Peoples established the **Treaties of Peace and Friendship** that recognized an ongoing peaceful relationship between them. As it was shown through **Residential Schools, Nunavik Dog slaughter**, and other **government efforts**, those treaties to coexist were **ignored and broken by the Canadian Government** for years.
- The **survivors** advocated for **recognition, accountability, and reparations** for the **intergenerational impacts** of harm caused, leading to the creation of the Truth and Reconciliation Commission.
- The Truth and Reconciliation Commission released a final report, detailing **94 calls to action**. These **actionable policy recommendations** embrace not only the **public sector**, and **government**, but also the **private sector and public in general**. [We all play a role in acknowledging history, repairing our relationships, and creating systems to prevent history from repeating.](#)

### What Reconciliation looks

#### like to the Mi'kmaq

- ⇒ **Recognition:** Recognizing and acknowledging the government policies that have led to injustices.
- ⇒ **Respect:** Cultivate an environment that honours Indigenous culture, celebrating and exploring their achievements and contributions.
- ⇒ **Responsibility:** Educate yourself and others about history and Indigenous culture.
- ⇒ **Action:** Support Indigenous peoples in asserting their inherent rights by using your voice and take action to move towards reconciliation.
