**Subject:** COVID Vaccine Product Availability Update

In the coming days, Omicron LP.8.1 variant vaccines will be available for ordering through your standard wholesaler.

There are no changes to the COVID Vaccine reimbursement process through PEI Pharmacare.

There are no changes to the McKesson distribution process. Shoppers Drug Mart and Loblaws pharmacies should order all vaccines through Matrix Distribution.

For pharmacies ordering through McKesson Distribution:

- **Pharmacies MUST place their order the day prior to delivery;**
- Delivery will occur ONCE per week on pre-determined days\*;
- Order cut-off times are based on the pharmacy’s assigned delivery day:
  - **Monday order cut-off at 2:00 pm for Tuesday delivery**
  - **Wednesday order cut-off at 2:00 pm for Thursday delivery;**
- It is the pharmacy’s responsibility to ensure the correct vaccine and quantity is ordered;
- **McKesson will distribute vaccines in quantities based on the above noted pack size\*;**
- Pharmacies should only order product intended for their store’s use;
- COVID vaccines available through McKesson Distribution are not available through Pharmacare Procurement.
- Expired COVID vaccine may be destroyed by the immunizer. Quantities and type of vaccine must be reported to the CPHO for inventory management using the **Vaccine Wastage Reporting Form.**
