Quality & Patient Safety Quarterly Review – Summer 2022



Health PEI's 2022 accreditation survey took place from June 12 to June 17, 2022. 12 Accreditation Canada surveyors were on-site for the week visiting 30 Health PEI programs/locations. A huge thank you to everyone who prepared for and participated in the on-site survey – your

hard work, time and energy is recognized and appreciated.

Feedback Shared During Survey Week

Many people shared they had positive experience meeting with the surveyors, sharing information, and learning how we can continue to improve quality and safety. Throughout the week, surveyors shared they had countless positive interactions with Health PEI staff, physicians, patients, clients, residents and families. Surveyors voiced they encountered people across the organization who were well prepared, open, and willing to engage and have conversations about our strengths and challenges.

Surveyors spoke highly of Health PEI staff and physician's dedication to the work you do, your patient/client/resident focus and your commitment to continuous quality improvement. Accreditation – Next Steps

A draft report from the surveyors was received on the final day of the survey week and feedback on the draft has been provided. We are now waiting for Accreditation Canada to finish our final report which will include whether Health PEI has received the award of accreditation and if any further follow-up is required for Health PEI to complete/submit as evidence. We anticipate receiving the final report until later this summer.

Once received, Health PEI's 2022 Accreditation Report will be shared with staff, physicians and the general public (similar to previous surveys). Please watch for future communication.

Late this summer and into the fall, Quality Improvement Teams, executive and program leadership will review the feedback provided in the 2022 accreditation report and identify and prioritize actions for further improvement.

As a reminder, the accreditation process is a four-year continuous quality improvement journey. The image below from Accreditation Canada describes the Qmentum (quality and momentum) process and illustrates where we are at currently in the accreditation cycle.
