PEI SMOKING CESSATION PROGRAM

PROGRAM OVERVIEW

Introduction

The PEI Smoking Cessation Program helps PEI residents who wish to stop smoking or using other tobacco products by: covering 100% of the cost of nicotine replacement therapy (NRT) products (i.e., nicotine gum, lozenges, patches, and inhaler) and specific prescription smoking cessation medication.

Your Options

Eligible PEI residents can be covered for one complete course (12 weeks) of the following two treatment options:



*Option 1: NRT products
(patches, gum, lozenges,
or inhaler)*



*Option 2: Prescription
smoking cessation
medication*





TREATMENT OPTION 1: Non-Prescription Nicotine Replacement Therapy (NRT) Products

The *PEI Smoking Cessation Program* covers the products listed in *Appendix A*. Once per year¹, eligible PEI residents can receive a single continuous course (12 weeks in a row) of **one** NRT product.

What you have to do

- 1) Make an appointment with a nurse at your nearest Primary Care Network office (*see Appendix B*) to discuss how ready you are to quit smoking and the supports available to you.
- 2) At your appointment, a nurse will go over the program intake form with you. The intake asks questions about how ready you are to quit smoking and your tobacco use. The intake also lays out a Cessation Action Plan, which describes the recommended treatment to help you quit.
- 3) Based on your medical history and past quit attempts, the nurse may suggest that you try an NRT product.
- 4) The nurse will review the guidelines of the **PEI Smoking Cessation Program** with you; both you and the nurse will sign the intake form.
- 5) You will take the Cessation Action Plan to your local pharmacy to pick up your NRT product.

NOTE: NRT products are available without a prescription. However, you must first see a nurse in your local Primary Care Network to enroll in the *PEI Smoking Cessation Program* and to determine whether these products are the best choice for you.



TREATMENT OPTION 2: Prescription Smoking Cessation Medication

The *PEI Smoking Cessation Program* covers two smoking cessation medication: bupropion (brand name Zyban®) or varenicline (brand name Champix®). Once per year², eligible PEI residents can receive a single continuous course (12 weeks in a row) of **one** prescription smoking cessation medication.

What you have to do

- 1) Make an appointment with a nurse at your nearest Primary Care Network office (*see Appendix B*) to discuss how ready you are to quit smoking and the supports available to you.
- 2) At your appointment, a nurse will go over the program intake form with you. The intake asks questions about how ready you are to quit smoking and your tobacco use. The intake also lays out a Cessation Action Plan, which describes the recommended treatment to help you quit.
- 3) Based on your medical history and past quit attempts, the nurse may suggest that you try a prescription medication.
- 4) The nurse will review the guidelines of the **PEI Smoking Cessation Program** with you; both you and the nurse will sign the intake form.
- 5) You will take the Cessation Action Plan and a prescription³ to your local pharmacy to pick up your medication.

NOTE: *PEI Smoking Cessation Program* coverage will not come into effect until you have exhausted any private health insurance coverage for these prescription medications.

FOR BOTH TREATMENT OPTIONS (NRT AND PRESCRIPTION SMOKING CESSATION DRUGS):

When you fill your prescription or pick up your NRT at the pharmacy for the first time, you will be given a 14-day supply. You must return to the pharmacy near the end of your second week of treatment to see the pharmacist; at that time, you will receive your next refill (28-day supply). Following that visit, you will receive another 28-day supply, and then a final 14-day supply to finish your 12 weeks of treatment.

³ Make an appointment with your primary care provider (i.e., family doctor or nurse practitioner) to get a prescription for this medication. If you do not have a primary care provider, discuss your options for getting a prescription with the nurse.

ONGOING SUPPORT

A combination of medication and counselling are known to be a better way to help people quit smoking than either alone.

If you would like counselling to help you with your quit attempt, you can make a follow-up appointment with your Primary Care Network nurse.

IF YOU TRIED TO QUIT BUT STARTED USING TOBACCO AGAIN

It often takes more than one try to stop smoking. That is why you can take part in the PEI Smoking Cessation Program more than once. However, you can only take part in the program once per year (from the date you entered the program).

The PEI Smoking Cessation Program covers a single continuous course (12 weeks in a row) of NRT or prescription medication. If the PEI Smoking Cessation Program already covered any treatment for you this year (e.g., you used a NRT product for a few weeks and then began smoking again), you are not eligible for more coverage until a year from the date you entered the program.

If you start smoking again in the same year you complete 12 weeks of treatment, you have to wait until the following year to enter the program again. However, you are encouraged to seek support to get ready for your next quit attempt; this will increase your chances of quitting successfully in the future.

Frequently Asked Questions

WHAT IS MY LOCAL PRIMARY CARE NETWORK?

There are five Primary Care Networks with offices across PEI. Each network has a team of health care professionals (e.g., family doctors, nurse practitioners, nurses, diabetes educators, etc.) Even if you don't have a family doctor – or your family doctor is not part of a Network – you are still able to access help at these offices for quitting smoking.

WHY DO I HAVE TO SEE A PRIMARY CARE NURSE TO ACCESS NRT?

You can get NRT products over-the-counter at a pharmacy. However, it is best to talk to a health care provider before using NRT, especially if you take any medications or have other health issues (such as diabetes, high blood pressure, or breathing problems). Your health care provider will consider these factors and create a Cessation Action Plan that meets your needs.

HOW DO I GET MY NRT?

Visit your local pharmacy and give them your Cessation Action Plan.

WHAT IF I CAN'T GET TO A PHARMACY TO PICK UP MY NRT?

If your local pharmacy does not provide delivery services, you could call another pharmacy that offers delivery.

HOW MUCH COVERAGE DO I GET EACH YEAR?

You get up to 12 weeks in a row of coverage for one NRT product or prescription medication each year (from the date you entered the program). You must pick up all your refills of NRT or prescription medication by the end of your 12 weeks of coverage.

HOW MUCH MEDICATION CAN I GET AT A TIME?

Medication will be given out on the **PEI Smoking Cessation Program** schedule. At your first visit to the pharmacy, you will get a 2-week (14-day) supply of NRT or prescription medication. At your next two visits, you will get a 4-week (28-day) supply. At your final visit, you will get another 2-week (14-day) supply to complete your course of treatment.

WHEN DO YOU START COUNTING THE 12 WEEKS OF TREATMENT?

The 12-week course of treatment starts the day you pick up your first 2-week (14-day) supply of NRT or prescription medication.

CAN I START TREATMENT, STOP FOR A COUPLE OF MONTHS AND THEN START AGAIN?

No. Research shows that people are more likely to quit smoking if they stick to a 12-week continuous course of treatment. For this reason, the **PEI Smoking Cessation Program** only covers a single continuous course of treatment (12 weeks in a row). Islanders are encouraged to complete the full 12 weeks of treatment to improve their chances of quitting.

HOW DO I GET REFILLS OF MY PRESCRIPTION MEDICATION?

If your primary care provider gave you a prescription for the full 12-weeks, simply visit your pharmacy to get your refills. If your primary care provider wrote you a prescription for a shorter course of treatment (e.g., 8-weeks), you will need to visit them again to see if you need more medication.

DO I HAVE TO RETURN TO THE SAME PHARMACY FOR MY NRT OR PRESCRIPTION REFILLS?

It is best to go to the same pharmacy for refills during the course of your quit attempt. Consistent follow-up and ongoing relationships with health care providers, including pharmacists, have been shown to help people quit successfully. However, if needed, you can pick up your NRT or medication refills at any pharmacy in PEI.

I STOPPED TAKING MY NRT/MEDICATION PARTWAY THROUGH MY 12-WEEK COURSE OF TREATMENT. CAN I START UP AGAIN AT A LATER DATE?

Once you get your first supply of NRT or fill your first prescription, your 12-week coverage period begins. You need to pick up all 3 refills of your NRT or medication before the end of the 12 weeks. After 12 weeks, you will not be eligible for coverage until the next year.

I HAD A REACTION TO MY NRT / MEDICATION. WHAT SHOULD I DO?

NRT and prescription medications can have side-effects: some are mild, while others are more serious. If you experience a mild reaction, discuss it with your primary care provider or pharmacist, or call 811 for advice; if the reaction is serious, call 911.

SWITCHING FROM ONE TREATMENT OPTION TO ANOTHER

If you want to switch to a different treatment option, you must discuss it with a Primary Care Network nurse, who will consult with the **PEI Smoking Cessation Program Coordinator**. Situations will be looked at on a case-by-case basis. If approved, you can start a new course of treatment. Otherwise, you must wait until the next year to be eligible for more coverage.

CAN I SUPPLEMENT MY NRT OR MEDICATION WITH ANOTHER NRT PRODUCT?

The **PEI Smoking Cessation Program** provides coverage for a single continuous course of one NRT product or prescription medication each year. Anyone who wants to use additional NRT products (e.g., short-acting lozenges or inhalers) must pay the costs themselves.

I DON'T HAVE A FAMILY DOCTOR. CAN I GET A PRESCRIPTION FROM A PHARMACIST?

PEI pharmacists can prescribe for many “minor ailments” including smoking cessation medications. However, in order to have the costs covered under the PEI Smoking Cessation Program, you must go through the intake process with a Primary Care Network nurse and get a prescription through a primary care provider (e.g., doctor or nurse practitioner).

CAN YOUTH (UNDER 19 YEARS) TAKE PART IN THE PEI SMOKING CESSATION PROGRAM?

If you are under 19 and interested in quitting smoking, contact your nearest Primary Care Network office to make an appointment with a nurse. The nurse will work with you to determine the most appropriate supports for you.

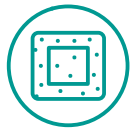

At your next two visits, you will get a 4-week (28-day) supply. At your final visit, you will get another 2-week (14-day) supply to complete your course of treatment.

WHEN DO YOU START COUNTING THE 12 WEEKS OF TREATMENT?

The 12-week course of treatment starts the day you pick up your first 2-week (14-day) supply of NRT or prescription medication.

CAN I START TREATMENT, STOP FOR A COUPLE OF MONTHS AND THEN START AGAIN?

No. Research shows that people are more likely to quit smoking if they stick to a 12-week continuous course of treatment. For this reason, the **PEI Smoking Cessation Program** only covers a single continuous course of treatment (12 weeks in a row). Islanders are encouraged to complete the full 12 weeks of treatment to improve their chances of quitting.

HOW DO I GET REFILLS OF MY PRESCRIPTION MEDICATION?

If your primary care provider gave you a prescription for the full 12-weeks, simply visit your pharmacy to get your refills. If your primary care provider wrote you a prescription for a shorter course of treatment (e.g., 8-weeks), you will need to visit them again to see if you need more medication.

DO I HAVE TO RETURN TO THE SAME PHARMACY FOR MY NRT OR PRESCRIPTION REFILLS?

It is best to go to the same pharmacy for refills during the course of your quit attempt. Consistent follow-up and ongoing relationships with health care providers, including pharmacists, have been shown to help people quit successfully. However, if needed, you can pick up your NRT or medication refills at any pharmacy in PEI.

I STOPPED TAKING MY NRT/MEDICATION PARTWAY THROUGH MY 12-WEEK COURSE OF TREATMENT. CAN I START UP AGAIN AT A LATER DATE?

Once you get your first supply of NRT or fill your first prescription, your 12-week coverage period begins. You need to pick up all 3 refills of your NRT or medication before the end of the 12 weeks. After 12 weeks, you will not be eligible for coverage until the next year.

I HAD A REACTION TO MY NRT / MEDICATION. WHAT SHOULD I DO?

NRT and prescription medications can have side-effects: some are mild, while others are more serious. If you experience a mild reaction, discuss it with your primary care provider or pharmacist, or call 811 for advice; if the reaction is serious, call 911.

SWITCHING FROM ONE TREATMENT OPTION TO ANOTHER

If you want to switch to a different treatment option, you must discuss it with a Primary Care Network nurse, who will consult with the **PEI Smoking Cessation Program Coordinator**. Situations will be looked at on a case-by-case basis. If approved, you can start a new course of treatment. Otherwise, you must wait until the next year to be eligible for more coverage.

CAN I SUPPLEMENT MY NRT OR MEDICATION WITH ANOTHER NRT PRODUCT?

The **PEI Smoking Cessation Program** provides coverage for a single continuous course of one NRT product or prescription medication each year. Anyone who wants to use additional NRT products (e.g., short-acting lozenges or inhalers) must pay the costs themselves.

I DON'T HAVE A FAMILY DOCTOR. CAN I GET A PRESCRIPTION FROM A PHARMACIST?

PEI pharmacists can prescribe for many “minor ailments” including smoking cessation medications. However, in order to have the costs covered under the PEI Smoking Cessation Program, you must go through the intake process with a Primary Care Network nurse and get a prescription through a primary care provider (e.g., doctor or nurse practitioner).

CAN YOUTH (UNDER 19 YEARS) TAKE PART IN THE PEI SMOKING CESSATION PROGRAM?

If you are under 19 and interested in quitting smoking, contact your nearest Primary Care Network office to make an appointment with a nurse. The nurse will work with you to determine the most appropriate supports for you.
